**Submission Deadline: September 18, 2020**

Winning artist receives \$2,500 stipend

Honorable mentions receive a \$250 stipend

### Eligibility

Professional artists over the age of 18 and living in Texas are eligible to enter.

### 2020 Submission Requirements

Artists are invited to submit one original work of art. The work must be respectful in nature as it will be located on the Plaza of the Cathedral, but ***does not have to be of a religious theme***. **No photography or computer generated art will be accepted.**

The submission should include:

- The original artwork
- A professional resume and a letter explaining how your entry will relate to the Plaza and the Arts District
- **Submissions MUST be 9 2/3 inches high and 28 inches long (the actual wall is 9 feet by 8 inches tall and 28 feet long.) These requirements exist to fit the exact proportion of the wall.**

The winning work will be digitally reproduced to mural-size dimensions and installed on the Art Wall. The work selected will be unveiled on the Plaza art wall in the fall of 2020.

### About The Catholic Foundation Plaza

The Catholic Foundation Plaza is a unique 3,900 square foot public space located at the Cathedral Shrine of the Virgin of Guadalupe, 2215 Ross Avenue, Dallas, Texas. The Plaza is located at the corner of Flora and Crockett Streets, directly across from the Meyerson Symphony Hall. The Plaza is in a highly visible location to visitors to the Dallas Arts District and is also one of the sites on the "Public Art Walk Dallas."
