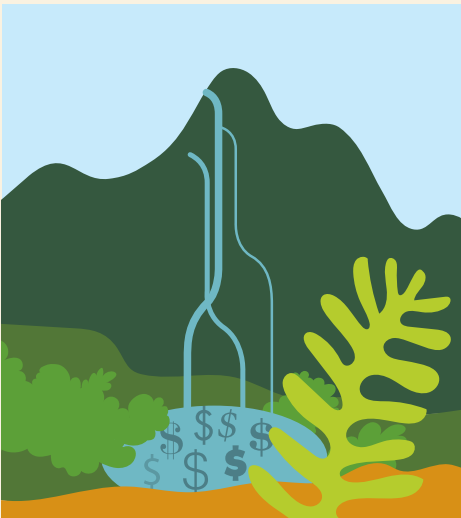

Benefits from Pooled Investments.



The Catholic Foundation has recently introduced some exciting new changes surrounding investments within the funds that have been established at the Foundation. Five model pools have been created to provide a low cost, institutional quality offering for donors.

These five model pools are:

- **MONEY MARKET POOL:** 100% in a money market fund
- **ULTRA CONSERVATIVE POOL:** 30% in a money market fund and 70% in high quality fixed income funds
- **CONSERVATIVE POOL:** 30% in US equities, 10% in a money market fund and 60% in high quality fixed income funds
- **BALANCED POOL:** 30% in US equities, 20% in international equities, 5% in a money market fund and 45% in high quality fixed income funds
- **GROWTH POOL:** 40% in US equities, 30% in international equities, 5% in a money market fund and 25% in high quality fixed income funds

Initially, the US equities portion of the pools will be indexed and the international equities component will utilize two active managers.

Donors will benefit from the new pool structure in various ways, including:

- Current and historic return information and market analysis on a timely and consistent basis
- Independent investment consultants continually monitoring each model
- Lower fees
- Additional investment options
- Access to managers that are closed to new investors
- Changes can be made quickly and efficiently.

Our donors are the most important constituents that we serve. We believe these changes will benefit our donors as well as our organization as we strive to impact our community in bigger and better ways going forward. PERMANENT IRA ROLLOVER GOOD NEWS FOR DONORS!

On December 18, 2015 President Obama signed the Protecting Americans (PATH) Act of 2015 which included legislation to permanently extend the IRA Charitable Rollover for 2015 and beyond. The bill allows people who are 70 ½ or older to transfer up to \$100,000 from an IRA to a qualified public charity free of federal income tax. The amount transferred can also be used to satisfy a donor's required minimum distribution (RMD).

Qualified IRA Charitable Rollover gifts to The Catholic Foundation can go to a charity of your

choice through a designated fund, scholarship fund or field of interest fund. Unfortunately, gifts cannot be made from an IRA to a donor-advised fund.

As an example: if you would like to make a gift from your IRA and create a designated fund at The Catholic Foundation that would provide funds for the support of your parish, your school or any other charity; or a gift to provide scholarships at a particular school; or you can also make a gift to the Foundation's unrestricted Philanthropy Fund to help meet the ongoing and changing needs in our Diocese.

Please remember you must notify your IRA custodian to make a direct transfer of the distribution amount from the IRA to The

Catholic Foundation. We can work with you to create a fund within the IRA Rollover guidelines that will support a charity or area of interest that is important to you.

The new law applies retroactively to charitable IRA distributions made any time during this 2015 tax year, and will continue to permit these IRA-funded charitable gifts into 2016 and future years.

Susan Stanzel

Civic leader Susan Heller Stanzel is a wife, mother of 5, grandmother of 15, fifth generation Texan, and has an extensive and impressive philanthropic leadership resume too long to list in this short article. Like her father before her, Susan believes the greatest honor she can receive is the "joy of doing for others" and, even as a young girl, has always volunteered graciously for the job no one else wanted to do. Susan Heller graduated from Ursuline Academy in 1957 and later that same year she married Tom Stanzel, an Air Force Officer. During their thirteen year journey around the globe, Susan's main passion was, and still is, selflessly volunteering to help others, her faith and Catholic values.

In 1970, Susan returned to Dallas and continued her tireless charitable work with Holy Trinity parish and later at Christ the King parish. Over the years she has volunteered her time and has served on dozens of highly-respected and well known boards and committees throughout the Dallas community. In 1985 Susan and her husband Tom co-founded the Cardinal Mindszenty Foundation

of Texas as a way to inform others about communism and public policy and to promote involvement in the Catholic Church through founding and growing multiple conferences featuring highly respected national speakers.

Susan's father, Frank Heller, was not only a powerful influence in the original founding of The Catholic Foundation, he was a former Chairman of the Board as well. IN MEMORIAM: THE REVEREND MONSIGNOR THOMAS W. WEINZAPFEL

On January 1, 2016, the Dallas Catholic community sadly lost one of its most treasured friends, Msgr. Thomas W. Weinzapfel. Father Tom, as his loved ones called him, died due to injuries he suffered from a fall he had on Christmas Eve, just 1 day following the celebration Mass and reception of his 70th Anniversary of Ordination. The December 23rd Anniversary celebration was attended by hundreds of his friends, colleagues and former parishioners at St. Pius X Catholic Church in Dallas.

Monsignor Weinzapfel, the longest serving diocesan priest of the Diocese of Dallas, served as pastor at St. Pius X from 1956-1996 before he retired after almost 41 years. Monsignor was a philanthropist as well as a priest and was a strong believer in charity, especially when it came to education. He was a powerful force in the founding of Bishop Lynch High school in 1963 where students and faculty will continue to enjoy the familiar Monsignor Weinzapfel

Atrium bearing his name. Father Tom was also a Catholic Foundation friend, donor, supporter, advocate, Legacy Circle member, and he gave many inspirational and memorable invocations for Catholic Foundations Award dinners and other events. Starting in 2001, he established several Charitable Gift Annuities as well as a Donor Advised Fund at The Catholic Foundation so that at the end of his life, the remainder of these gifts will be used by the Foundation to support what Monsignor termed in 2001 as “those programs that will represent what will then be the greatest needs of the Diocese.”

“On behalf of the Trustees, Officers, and staff of The Catholic Foundation, we would like to express our deep appreciation and gratitude for our friend Father Tom,” says Matt Kramer, President and CEO. “Like so many supportive clergy members before him including our Founder Bishop Thomas K. Gorman, his advocacy and physical presence will be greatly missed. His influential legacy lives on, and we will always remember Father Tom for his love, dedication and support of The Catholic Foundation.”
