Their three-year term, effective January 2019, adds additional strength to the organization's Board of Trustees.

**G. Marc Lyons** joined The Catholic Foundation Board of Trustees in 2014. He has served as Vice Chairman and Chairman of the Investment Committee, and also served on the Audit and Administration, Development and Governance Committee. His business career spans 45 years in the oil and gas industry in various positions for Texaco, Southern Natural Gas Company, Enserch Corporation, Energy Transfer and Crosstex Energy. In 2017, he retired as president and partner of Cardinal Midstream. Lyons obtained a bachelor's degree in quantitative management from Nichols State University and completed Harvard University's Program for Management Development. Lyons and his wife, Georgia, attend All Saints Catholic Church in Dallas.

**Matthew Bowen,** has worked with FIS since 2004. At the financial services company, Bowen serves as Group Executive & General Manager of the Check & Document Imaging Solutions division.
