

## Kevin Cardinal Farrell Coming Home to Dallas to Receive the 2018 Catholic Foundation Award

Prefect of the newly established Dicastery for Laity, Family and Life in the Vatican.

"The Catholic Foundation Award honors an individual or couple for distinguished service and support to further the religious, charitable and educational needs within our Diocese. We are honored and humbled that Cardinal Farrell will accept this award in 2018, and plans are in works for a fantastic event to convey our gratitude," said Matt Kramer, president and CEO of The Catholic Foundation.

Cardinal Farrell will travel to Dallas for The Catholic Foundation Award Dinner on Saturday, Feb. 3, 2018, at the Hilton Anatole.

"I believe Cardinal Farrell is coming home to receive The Catholic Foundation Award because of the great respect he developed for The Catholic Foundation when he saw firsthand the good work they were doing. Plus,

I know he will enjoy seeing his legion of Dallas friends again," said Mike Corboy, Advisory Council member and recipient of the 2005 Catholic Foundation Award. "Cardinal Farrell rejuvenated the Diocese in many ways while building a team of talented professionals to continue the momentum he established."

Cardinal Farrell was appointed the seventh Bishop of the Roman Catholic Diocese of Dallas by Pope Benedict XVI and installed at the Cathedral Shrine of the Virgin of Guadalupe in Dallas on May 1, 2007.

"My favorite memory of then Bishop Farrell was the day I first met him shortly after he arrived in Dallas," said Mike. "He showed up totally unannounced to participate in the funeral mass for Sister Pauline Mullen, a wonderful Irish nun, after reading her obituary. Classic Bishop Farrell!"

As we approach the end of the year donors tend to think about their end-of-year charitable giving to support their favorite charities. If you are over 70 ½ you can take advantage of a simple way to benefit the charities you care about and receive tax benefits in return by making a gift from your IRA. # EFFECTIVE CHARITABLE GIVING WITH YOUR IRA

With federal income taxes in the United States starting at 25% for taxable income over \$37,950 for a single taxpayer (over \$75,900 for a married couple) and a federal estate tax bracket of 40%, we should make our charitable giving as tax effective as we can. Imagine, being able to give so much more or save more, by making simple changes in the way you make your annual or capital campaign gifts!

## What is the most tax effective lifetime charitable giving option?

Individuals who are over 70  $\frac{1}{2}$  have a wonderful, effective way to make gifts to charities.

Annually a donation from their IRA, inherited IRA or inactive SEP IRA up to \$100,000 to a public charity qualifies for this technique.

The gift counts as part of the annual required distribution from the IRA and <u>it is not includible in their taxable gross income</u>. Depending on their tax bracket, it may reduce

their taxable social security benefits, Medicare "B" premiums, the 3.8% Medicare surtax on investment income, and/or reduce the loss of itemized deductions. Consult with your CPA or tax attorney to understand how this affects you personally.

The check must be made payable to a public charity. Donor advised funds do not qualify. However, if the check were made out to The Catholic Foundation, it could be directed to a specific cause within the Foundation. The donor must get a letter from the charity indicating that the donor received no goods or services in exchange for the gift.

# What is the most effective charitable giving approach for an estate?

For those faced with estate taxes (estates greater than \$5,490,000), the combined effect of the federal estate and income taxes for funds in IRAs and qualified retirement plans can result in taxes 50% and higher. Individuals with these large estates can be even more effective in their charitable giving by using their IRA, SEP IRA, and 401(k) and 403(b) plans. An

outright gift from one of these can avoid taxes completely on the amount given to the charity.

Other techniques such as a Charitable Remainder Trust can benefit both a charity and your non-charitable beneficiaries. While these can bring substantial tax benefits, they are complicated and should be thoroughly discussed with a qualified estate planning attorney.

If you are considering this type of a gift call your broker in the early part of December in order to allow time to make the necessary transfers and also work with the Foundation to plan what charity or charities you would like to support.

### CONGRATULATIONS TO THE 2017-2018 JETHSUBY SCHOLARS

Texas Scottish Rite Hospital for Children was filled once again with the smiling faces of families and donors at the annual 2017
Jethsuby Scholarship Dinner on Aug. 26. Like the scholarship program itself, this incredibly special evening honoring elementary students and their families has grown each year. This year's guest of honor was The Most Reverend Gregory Kelly, Auxiliary Bishop of the Diocese of Dallas. WFAA Anchor Cynthia Izaguirre returned as the MC for the evening.

Since the fund's inception in December 2009, The Jethsuby Scholarship Fund of The Catholic Foundation has helped 49 Hispanic children with their Catholic elementary school tuition. In 2016-2017 alone, the Jethsuby Scholarships helped 20 students with over \$45,000 in tuition funding. The students are awarded a scholarship based on excellent academic performance, school and community participation by the student and family as well as financial need as determined by the scholarship selection committee.

Support for this fund grows each year, and the ultimate goal of the fund remains the

same – raising \$1 million to be awarded in scholarships. Dr. Mauricio Delgado, director of neurology at Scottish Rite Hospital for Children and professor of neurology at The University of Texas Southwestern Medical Center at Dallas, and his wife Maria, established and named The Jethsuby Scholarship Fund in honor of one of his patients, Jethsuby. A son of Mexican immigrants, Jethsuby died at age 11 in a tragic motor vehicle accident. Catholic Foundation donors Dr. and Mrs. Delgado felt called to help other deserving Hispanic children attend Catholic schools, and established this fund as a vehicle to carry out that vision.

The Jethsuby Scholarship Fund is just one of the Scholarship Funds that have been established by various donors at The Catholic Foundation.
