THE STATE OF THE ESTATE TAX

It sounds like a pretty good idea: no estate taxes this year.

•••••

It is actually a very complicated idea, one fraught with uncertainty in these challenging economic and contrary political times.

What's an individual to do? How does one's estate plan work (or does it work at all?) when, one year, there's a \$3.5 million estate

tax exemption and a 45 percent post-exemption tax rate, and the next year there's no exemption and no estate tax at all, but the potential for huge capital gains taxes? And what if, the next year, all bets are off and estate taxes return, as currently legislated, to what they were prior to the Bush tax cuts, with an exemption of \$1 million per estate and a post-exemption tax rate of 55 percent?

These significant changes makes estate planning difficult. At the Foundation, we encourage our donors and potential donors

to work with their professional advisors to keep their estate plans flexible and up-to-date, and to take advantage of every opportunity to direct their resources precisely where they want them to go – to family members and other heirs and to charities of their choice – rather than to taxes.

STEP RIGHT UP! Take a chance!

For good or bad, right or wrong, the Catholic Church has a long-standing association with Bingo games. And raffles. And auctions. And Poker tournaments.

So what's a law-abiding, Catholic, fund-raising nonprofit organization to do in a state where gambling is otherwise illegal? Attorney Tyree Collier, a partner with Thompson & Knight LLP, shared his expertise and counsel with a full house (pardon the pun) at the spring meeting of The Catholic Foundation's Catholic Community Network.

He informed the audience what contributions qualify for a charitable deduction and he underscored the importance of the charitable event chairmen consulting with lawyers to make sure they are in compliance with the legal issues of fundraising via charitable raffles, poker tournaments, auctions and other gaming activity.

In sum: Don't take a chance. Consult your attorney. And follow the law.

A LIGHT On

TURNING THE PAGE TO HELP STUDENTS LEARN

It is impossible, really, to get an education — even in the best of Catholic schools — if you cannot read. But if you cannot read because of vision loss or impairment, a physical disability, a learning difference such as dyslexia, or an English language deficiency, Reading & Radio Resource will "read" for you.

Recently the 41 year-old Dallas organization created an Audio Recordings Seed Library of textbooks, literature, newspapers, magazines, and other printed materials for the Dallas Catholic Diocesan Schools, using funding from a Catholic Foundation grant of \$7,600.

Library "a great educational resource," It should be noted that the tapes can be duplicated free of charge, and distributed to any Catholic school in the Diocese.

Betty Hersey, Executive Director of Reading & Radio Resource estimates that of the 15,000 children enrolled in Diocesan schools, as many as 3,000 could benefit from the recordings. "I know audio recordings help children do better in school, and keep them from dropping out," she says. "Teachers tell us the audio materials help students participate in class and better understand the material."

In addition to recordings for school children, Reading & Radio Resource records books

one provided scholarship funds before his tragic death in a traffic accident at age 11.

The scholarships will fund up to 50 percent of tuition costs in Diocesan Catholic elementary schools. The donors hope to raise a total of \$2 million over the next two years from others who share their generous vision. Already, in addition to their contribution, they have enlisted the support of the Mexican actor Alberto Mayagoitia, who offered two fundraising performances of his one-man show Mi Cristo Roto at the Cathedral Shrine of the Virgin Guadalupe. According to Bishop Kevin J. Farrell, approximately 24 percent of the 15,000 students in Catholic diocesan and private Catholic schools are Hispanic. The number would probably be higher, he said, if financial assistance were available for more families, and he welcomed the Delgados' commitment to this new scholarship. "We know there is a need."

The Catholic Foundation currently manages 17 scholarship funds established by private donors, works with the donors to establish specific criteria for the awards, administers the application and grants process, and handles reporting and distribution requirements.

In his recommendation, former Foundation Trustee Bob Baillargeon, noted the grant is intended "to help children do better in school, especially those children who need the most help."

Sister Dawn Achs of the Catholic Schools of Dallas office, with principals and teachers, assisted in the selection of materials to be taped by the agency's volunteers, and maintains the master library of recordings on cassette tapes and/or MP3 CD's. Calling the new

and other printed materials for adults, and operates a radio reading service, Station NTRB. Volunteer readers annually donate approximately 16,000 hours and record more than 200 books a year.

"We know what a Catholic education did for our children and we would like to help provide that same opportunity for others."







